Section 3 - COMPOSITION / INFORMATION ON INGREDIENTS

Composition:

Contains per ml: 4.457 mg metoclopramide (as hydrochloride monohydrate) equivalent to 5 mg metoclopramide hydrochloride, CAS RN 7232-21-5, 54143-57-6.

Section 4 - FIRST AID MEASURES

SWALLOWED

- Immediately give a glass of water.
- First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

EYE

In case of accidental exposure by spillage into the eyes, wash immediately with abundant water. If adverse effects appear, seek medical advice immediately and show the package leaflet or the label to the physician.

Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.

SKIN

Wash hands after administration to the animal.

Section 6 - ACCIDENTAL RELEASE MEASURES

MINOR SPILLS

- Clean up all spills immediately.

SWALLOWED

■ The material has NOT been classified by EC Directives or other classification systems as "harmful by ingestion". This is because of the lack of corroborating animal or human evidence.

EYE

■ Although the liquid is not thought to be an irritant (as classified by EC Directives), direct contact with the eye may produce transient discomfort characterised by tearing or conjunctival redness (as with windburn).

SKIN

CHRONIC HEALTH EFFECTS

Section 13 - DISPOSAL CONSIDERATIONS
